Subsequently, as per D.O. letter vide No.1 CS/ REV/2011, dt. 28/10/2011 issued by the Chief Secretary, Tripura the Khowai District has been formed and posting of Sri Tarun Kanti Bhowmik, Tehshilder, Accused Officer is at SDM's Office, Khowai under Khowai District.

WHEREAS, Sri T.K. Bhowmik, Tehshilder has lastly present in the office of the SDM, Khowai on 12th and 13th December, 2011 and on 26/12/2011 he has applied for 30(thirty) days Commuted Leave on Medical Ground w.e.f. 14/12/2011. His Leave address during Leave period mentioned as Tripura Bhavan, Kolkata Saltlake as per Radio Message of SDM, Khowai issued to the S.P., CID, Agartala vide No.9573-77/SDM/KH/ESTT/2012, dt.01/03/2012.

WHEREAS, Sri Bhowmik, TDR is still absenting from his duties for long w.e.f 14/12/2011 and no application has also been received after his last application dated 21/04/2012 where he applied for 160 (one hundred sixty) days commuted leave in addition to his leave for 130 (one hundred thirty) days w.e.f 14/12/2011 as per letter of the SDM vide No. 3012/F.1 (7-392)/SDM/KH/ESTT/11 dt. 03/09/2012.
